The order of the District Hearing Officer, issued 11/27/2024, is affirmed.

It is the order of the Staff Hearing Officer that the Injured Worker's C-86  
Motion filed 09/06/2024 is denied.

It is the order of the Staff Hearing Officer the claim is DISALLOWED for L3-L4  
HERNIATED NUCLEUS PULPOSUS and L4-L5 HERNIATED NUCLEUS PULPOSUS.

The Hearing Officer finds the disallowed conditions are not causally related to  
the industrial injury of 03/31/2023 by direct causation, flow through, or  
substantial aggravation.

The Hearing Officer relies on the report of Michael Rozen, M.D. dated 09/20/2024  
in which Dr. Rozen opined that the conditions were degenerative in nature with  
insufficient evidence of substantial aggravation.

The Self-Insuring Employer is hereby ordered to comply with the above findings.

All of the evidence was reviewed and considered in rendering this decision.
