**COMPLAINT**

**COUNT ONE**

1. On November 24, 2023, and at all times material herein, Plaintiff insurance company was the insurer, assignee, and subrogee of Jordan Arends, who was the owner of a 2020 Nissan.
2. On November 24, 2023, on Thurman Avenue in Columbus, Ohio, the Defendant negligently operated a motor vehicle in such a manner to damage Plaintiff's insured Jordan Arends' motor vehicle in the amount of \$18,956.50.
3. Plaintiff insurance company was required to and did pay to its insured the sum of \$18,956.50, subject to a \$500.00 deductible, and became subrogated to said amount.

**COUNT TWO**

4. Plaintiff realleges and reiterates paragraphs 1 through 3 as if fully rewritten and restated herein.

5. On November 24, 2023, and at all times material herein, Plaintiff insurance company was the insurer, assignee, and subrogee of Alayna Reis, who was the owner of a 2021 Jeep.

6. On November 24, 2023, on Thurman Avenue in Columbus, Ohio, the Defendant negligently operated a motor vehicle in such a manner to damage Plaintiff's insured Alayna Reis' motor vehicle in the amount of \$11,081.75.

7. Plaintiff insurance company was required to and did pay to its insured the sum of \$11,081.75, subject to a \$500.00 deductible, and became subrogated to said amount.

Wherefore, Plaintiff demands judgment against the Defendant in the total amount of \$30,038.25, plus statutory interest, plus the costs of this action.
