COMPLAINT

1. On August 18, 2022, Plaintiff, Marcus P. Stanford, was an employee of Defendant, Ccbcc, Inc., working in Franklin County.

2. On August 18, 2022, during the course of and arising out of his employment, Plaintiff sustained a compensable injury.

3. On August 18, 2022, Defendant, Ccbcc, Inc., was amenable to the Workers' Compensation Act and paid compensation and benefits directly to its employees for any compensable injury suffered by them in the course and scope of their employment as provided by the Ohio Revised Code.

4. Plaintiff timely filed an application for benefits for his injury with the Bureau of Workers' Compensation to which Claim No. 22-181145 was assigned.

5. The self-insured Employer denied the application and the matter was referred to the Industrial Commission for a hearing.

6. By order dated January 26, 2023, and mailed January 31, 2023, a District Hearing Officer denied Plaintiff's application and denied the claim.

7. Plaintiff timely appealed the decision of the District Hearing Officer and by order dated March 16, 2023, and mailed March 21, 2023, the Staff Hearing Officer denied Plaintiff's appeal.

8. Plaintiff timely appealed the decision of the Staff Hearing Officer, and by order dated April 7, 2023, and mailed April 11, 2023, the Industrial Commission refused to hear Plaintiff's appeal.

9. The decision of the Commission was a final decision denying Plaintiff the right to participate in the Workers' Compensation Fund of Ohio.

10. On July 10, 2017, Plaintiff timely filed his Notice of Appeal and Complaint with this Court to which case number 23CV-06-004059 was assigned.

12. On June 12, 2024, Plaintiff voluntarily dismissed his action without prejudice, pursuant to Civ. R. 41(A)(1)(a).

13. Plaintiff now refiles his Complaint, pursuant to R.C. 2305.19

WHEREFORE, Plaintiff asks that he be found entitled to participate in the Workers' Compensation Fund of Ohio and asks such other relief as the Court may deem appropriate, including costs and attorney fees.
